

Facts	What does Savannah Schools Federal Credit Union (SSFCU) do with your personal information?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	 The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security Number and information we receive from you on applications & other forms Loan payment history and information about your transactions with us Name & address data and information web receive from a consumer reporting agency When you are no longer our member, we continue to share your information as described in this notice.
How?	All financial companies need to share member's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members personal information; the reasons Savannah Schools Federal Credit Union chooses to share; and whether you can limit this sharing.

What You As A Member Can Do To Help: Protect your account numbers. plastic card numbers, PIN's (personal identification numbers) and passwords. Never keep your PIN with your card, which can provide free access to your accounts if your card is lost or stolen. If someone calls you explaining the call is on behalf of the Credit Union and ask for your account number or SSN, you beware. Credit Union staff has access to that information and will not need to ask you for it. Keep your information with us current address, phone numbers, etc. If we detect potentially fraudulent or unauthorized activity or use of an account, we may need to contact you immediately. 
